

They have played key roles on many bills that were considered, passed, and in some cases, signed into law. Looking forward, ASHRAE is well-positioned to build on last year's accomplishments.



2014 Warmest Year on Record

GENEVA—2014 was the Earth's warmest year on record. The World Meteorological Organization (WMO) this week agreed with NASA, NOAA and the Japanese Meteorological Agency, all of which made similar announcements recently. The WMO, a United Nations agency, reported the average global air temperature in 2014 was 1.03°F (0.57°C) above the long-term average of 57.2°F (14°C). That means 2014 was slightly warmer than 2010 and 2005, the previous warmest two years. WMO Secretary-General Michel Jarraud said in a statement that "Fourteen of the 15 hottest years have all been this century."

2016 Federal Budget Proposal Includes \$48 Billion for Energy-Efficiency Programs

WASHINGTON, D.C.—President Barack Obama's budget proposal for 2016 asks Congress for \$4 trillion, including about \$48 billion in tax incentives over the next decade for various green energy programs. "In order to secure America's energy future and protect our children from the impacts of climate change, the budget invests in clean energy, improving energy security, and enhancing preparedness and resilience to climate change," according to a White House fact sheet on the 2016 budget proposal. The proposal includes provisions to incentivize green energy production, expand use of energy-efficiency measures, and increase investments in carbon capture technology.

U.S. Government's Energy Use Declining

WASHINGTON, D.C.—The U.S. federal government, with thousands of facilities and vehicles in locations across the United States and abroad, is one of the largest energy consumers in the world, but its consumption is declining. According to the U.S. Department of Energy's Federal Energy Management Program (FEMP), total delivered-to-site energy use by the federal government fell to 0.96 quadrillion Btu in fiscal year (FY) 2013, the lowest recorded since 1975. These years are the most recent and the earliest, respectively, for which data are available. In FY 2013, vehicles and equipment energy use accounted for 62% of all federal energy consumed, with the remainder consumed by federal facilities. Energy consumed in federal government facilities has generally been declining over the past four decades. The reduction stems from both the total square footage occupied by the federal government, which continues to fall from its peak in FY 1987, and from the energy consumed per square foot inside federal buildings, which has been declining since FY 1975.

This agreement comes after a seven month period of due diligence, which was completed last month.

We are excited about the opportunities presented by this consolidation. It opens the door to alignment of ASHRAE and IAQA programs to create high-impact resources for building professionals around the globe.

IAQA is a nonprofit organization dedicated to bringing practitioners together to prevent and solve indoor environmental problems for the benefit of customers and the public. IAQA was established in 1995 and is the nation's largest indoor air quality trade association with over 2,600 members and more than 20 local chapters across the United States and Canada.

As I share this news with you today, IAQA President Kent Rawhouser also is sharing the news with their members. He says, "This is an historic event for both associations and has great promise for growth and

development for both organizations. The opportunities and possibilities for members are only limited by our own imaginations. IAQA and ASHRAE are committed to growing and developing the IAQA brand. The consolidation will open new avenues for programs and benefits for our members."

Under the consolidation, IAQA will become a part of the ASHRAE organization while maintaining its own brand and Board of Directors. IAQA will operate independently within ASHRAE's organizational structure.

This consolidation allows ASHRAE and IAQA to combine resources to improve indoor air quality in the built environment. We are optimistic about what the agreement means to the future of both groups.


