2017 AHR Expo Largest in Show's History

WESTPORT, Conn.—The nine football fields worth of exhibitor space at the 2017 AHR Expo in Las Vegas Jan. 30–Feb. 1 will make it the largest Show in the exposition's history, surpassing Chicago in 2015, organizers said. "We are declaring the Show the largest ever," Clay Stevens, Show Manager of the AHR Expo, said in an interview Tuesday. "It's very exciting." Stevens attributed the increased exhibitor space to renewed optimism in the industry. "Many exhibitors have taken larger booth spaces anticipating that a more robust economy coupled with an exciting Show location like Las Vegas will energize attendees. We're expecting over 60,000 industry professionals." That optimism, he said, was reflected in an annual economic survey of exhibitors conducted by IEC and ASHRAE Journal that was released Dec. 20.

DOE Issues New Final Rules for Several HVAC Equipment Categories

WASHINGTON, D.C.—The U.S. Department of Energy (DOE) closed out 2016 on Dec. 28 by unveiling new regulations covering a range of HVAC technologies. The final rules provide energy-efficiency standards for commercial boilers, portable air conditioners, swimming pool pumps, and walk-in coolers and freezers. Another, non-HVAC-specific, rule concerns uninterruptible power supplies. The rules would save consumers and businesses between \$15 billion and \$35 billion over the 30-year lifetime of the products, according to DOE. Most of the rules have a 45-day review period—until Feb. 11—before they can be made official via publication in the Federal Register. The swimming pool pump rule has a 110-day review period. This means their ultimate approval will be under the authority of the next presidential administration.

Solar Power Capacity Likely Outpaced Natural Gas, Wind in 2016

WASHINGTON, D.C.—In 2016, for the first time, more electricity-generating capacity from solar power is expected to have been installed in the U.S. than from natural gas and wind, according to the U.S. Department of Energy (DOE). Though the final data won't be available until March, enough new solar power plants were expected to be built in 2016 to total 9.5 GW of solar power generating capacity. That is triple the new solar capacity built in 2015. The solar farms built in 2016 are expected to exceed the 8 GW of natural gas power generating capacity and the 6.8 GW of wind power added in 2016. No new coal-fired power plants were planned in 2016. "If 2016 planned additions pan out as operators initially expected for 2016," said Tim Shear, an economist for the U.S. Energy Information Administration, "it would mark the first year that solar was the largest source of capacity." U.S. solar power generation is believed to have grown by 44% in 2016 and is expected to grow more than 30% in 2017.



ASHRAE Publishes 2016 Versions of Refrigerant Standards

Thirty new refrigerants and refrigerant blends have been added to the recently published 2016 editions of ASHRAE's major refrigerant-related standards. ANSI/ASHRAE 15, Safety Standard for Refrigeration Systems, and its sister standard, ANSI/ASHRAE 34, Designation and Safety Classification of Refrigerants, were published this week as a package. The 2016 edition of Standard 15 incorporates five addenda to the 2013 version. Among its changes are updated requirements for safety relief systems, updated design pressure requirements for systems using carbon dioxide, and modified overpressure protection for heat exchangers and pressure limiting devices for positive displacement compressors. The 2016 edition of Standard 34 incorporates 35 addenda to its 2013 version. Key changes include the addition of three new refrigerants and 27 new refrigerant blends.

ASHRAE Seeks Presenters for Business Performance Analysis Conference

ASHRAE has announced a call for presenters for the 2017 ASHRAE Building Performance Analysis Conference, formerly known as the ASHRAE Energy Modeling Conference. This year's conference expands on the core subject of energy modeling to encompass non-energy building performance analysis and simulation for professionals responsible for such work. Topics include modeling for and during the design phase; modeling innovative or new technologies; data visualization; and future trends in modeling. Presentation proposals on these and other topics are due March 13, and decisions will be announced April 3. The 2017 ASHRAE Building Performance Analysis Conference will be held Sept. 27–29 in Atlanta.
